So between now and June consider what you can do to attract the general public, with a theme of green issues and recycling making use of anything you would normally throw away. The event will be held at Mirfield Show Ground and we will email details as the plans develop. Emma Summers Parks Development Officer has worked on the details and Sam from Huddersfield Live helped with the planning. It is planned to have a Hay Bale session for talk and activities with children and families. There will be very little parking but there is the bus or train from Huddersfield and the greenway runs very close for cyclists. Mirfield in Bloom are holding a planting session on Sunday and another stall will be showing ideas for reuse of rubbish. Monitoring and Surveys as well as management of land will be covered. ## **Any Other Business**

Tomorrow is the start of Keep Britain Tidy Great British Clean Up month if anyone wants to take part. Quite a few of the groups have regular clean up days.

We can provide training for Stage 1 Walk Over Surveys to groups. We have 3 Ecologists who hopefully will have a date to train people at East Hill Woods. Dave Hemingway will train and give books out. We could do a further 4 sites if anyone wants to learn. Wilton Park are looking to do a bioblitz in the summer maybe we could do a training there. Dave arranged with Simon River Home Connection to enable monitoring on the Dearne. We would appreciate a report for the website. Using RHC experts on weed control, we will ask for funding for this. Birkby Garden has Japanese Knotweed. RHC has training for Japanese Knotweed from 29<sup>th</sup> July for 4 days in Holmfirth details on the NK website.

Tim Scott mentioned that he had seen a winch used to pull out roots. He also said that the Middle School had a teacher who was an environmentalist and was looking for fruit trees. Aspens are being planted at Dewsbury Country Park. The Woodland Trust has trees available. Northern Fruit Group has an office near Flint Street. Hilary will be doing pruning courses and will have trees in the future for a small donation. Bruce said that Kirklees has maps which on some levels may be available to the public. Patrick said he had access and groups should ask their VC's whether they can access a particular site. We should ask if we can have a specific layer for Natural Kirklees. Steve Moorhouse said Wilton Park Woodland contains landscape from the pre historic period and there are a lot of ancient gardens and pre historic round houses. He could give a presentation at a future meeting.
