Structure, governance and management

The charity is a Charitable Incorporated Organisation (CIO) formed on 15 August 2017.

Charity Reconstruction

At 15 August 2017 the unincorporated association Natural Kirklees was dissolved and transferred its assets to Natural Kirklees (charity number 1174259). The purpose of the transfer was to give the existing organisation an incorporated charity structure.

During the reconstruction there has been no significant change to the beneficiary class, the purposes for which funds are held or the persons who constitute the trustee body.

For this reason, the principles of merger accounting have been applied in stating the comparatives. Since the accounts have been prepared on a receipts and payments basis, no further notes regarding this reconstruction are required.

No significant adjustments have been required in aligning the accounting policies.

Method of recruitment and appointment of trustees

The trustees of the charity are appointed by the members at the AGM.

Objectives and activities

The charity's objects

- 1. To promote for the benefit of the public the conservation, protection and improvement of the physical and natural environment in Kirklees by promoting biological diversity.
- 2. To advance the education of the public in the conservation, protection and improvement of the physical and natural environment.

The charity's main activities

Umbrella organisation for volunteer groups in Kirklees promoting conservation and biodiversity. Providing free insurance and tool share for groups working on Kirklees green spaces.

Public benefit statement

In setting our objectives and planning our activities our Trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular giving help and support to the 94 member volunteer groups who work tirelessly to improve their green space, hold events to raise funds and most importantly bring the local community together. The final outcome is £1,000,000 in volunteer time improving green spaces and looking after the environment, conservation, education and guidance on working practices, grants, exercise, fresh air, good company and a healthy feeling.

Achievements and performance

We currently have 94 volunteer groups on the Natural Kirklees website directory, 60 of these have taken up the insurance scheme and a number of them use the tool stores.

Quarterly meetings are held to bring groups together, to discuss common problems and hopefully resolve problems by liaising with the volunteer co-ordinators. Tool sharpening was demonstrated at the last meeting. Wildlife sightings are reported and discussed. At the annual fete groups are encouraged to showcase their work.

Kirklees Volunteer Co-ordinators are a great help to groups and arrange work days for firms and individuals who volunteer under corporate responsibility provision.

Peace Pit Poly Tunnel Group run by s2r and volunteer co-ordinator is very busy now growing plants for parks and green spaces and schools. Volunteers meet each week to plant seeds, prick out plants and grow vegetables. The entry for the Harrogate Spring Flower Show was a very good example of council staff and volunteers working together to achieve a Silver Gilt Medal and the Newby Cup.

We continue to improve the website and get information to groups by newsletters, on the news section of the website and via social media. The strategic action plan has progressed in all areas.

In the future we will extend the website to include Bioblitz information, surveys of the biodiversity at each green space and carry out a skills audit on our volunteers to create a network of groups and individuals helping each other.

Financial review

Net expenditure for the year was £8,310, all relating to restricted funds.

Reserves policy

The charity's free cash reserves at the year end were nil. (All funds held are restricted).

The charity has no formal reserves policy. All project funds are restricted and the group have no liabilities beyond the running of the funded activities.
